- **Establishment of Anti Corruption Unit and National Council Against Corruption as independent two-tiered system**
- **2015 Second Phase of Anti-Corruption Strategic Plan and Action Plan adopted**
- **3 Pronged Approach:**
 - **Education**
 - **Prevention**
 - **Law Enforcement**

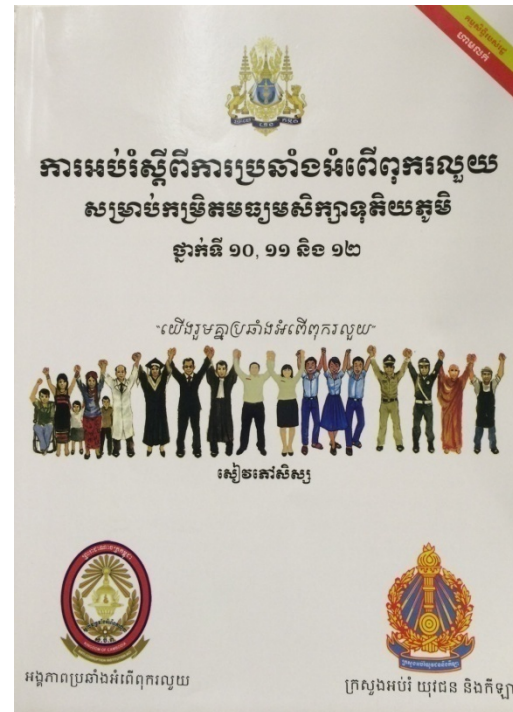
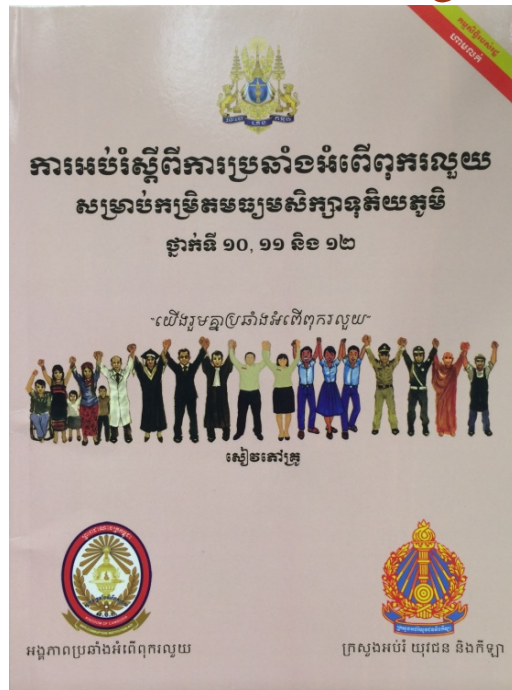
ACU Undertaking 2 distinct ways:

1. In-School Program

Anti-Corruption Education for High School is designed by ACU & M. of Education: Student's Textbook and Teacher's Guidebook (Grades 7 to 12) – Primary Level Grades and Higher Education Level will be developed next year



NB: English Version is being prepared for Cambodian High Schools that use English as medium of instruction.

MODULE DESIGN

- Grades 10-12: 12 Modules - 4 Modules for each grade

- Grades 7-9: 12 Modules - 4 Modules for each grade



MODULE DESIGN: Sample of Module

- The content of some modules :

Module 1: Good & Law-abiding Citizen

☆ To guide student the values of good citizens, to behave morally, to abide by the law, to respect the others



Module 4: What is Corruption?

☆ To be able to identify Corruption (Actors – Causes -Activities – Effect/Impact)



Module 6: Causes and Effects of Corruption

☆ To be able to understand the society role and make the right decision in the situation vulnerable to corruption



Module 7: Mass Media and Anti-Corruption

☆ To know more about mass media and its feasibility to fight against corruption

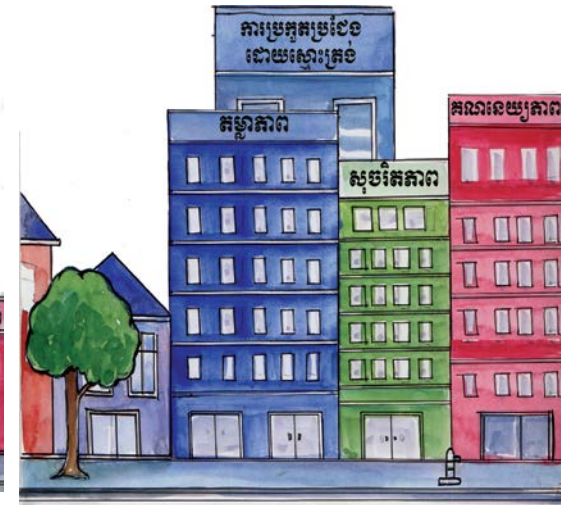


Module 8: Anti-Corruption in Private sector

☆ To be able to understand roles and feasibility to fight against corruption from private sector



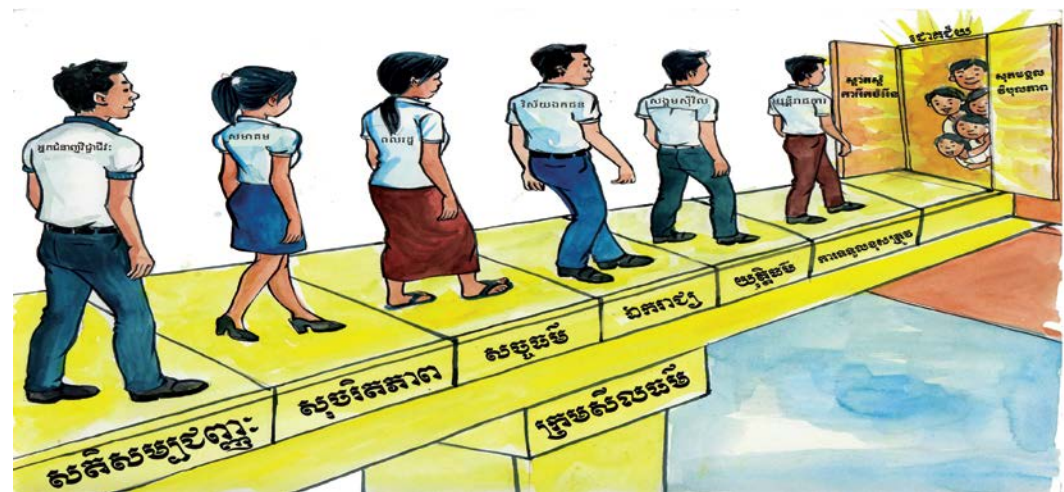

PREPARATION FOR IMPLEMENTATION

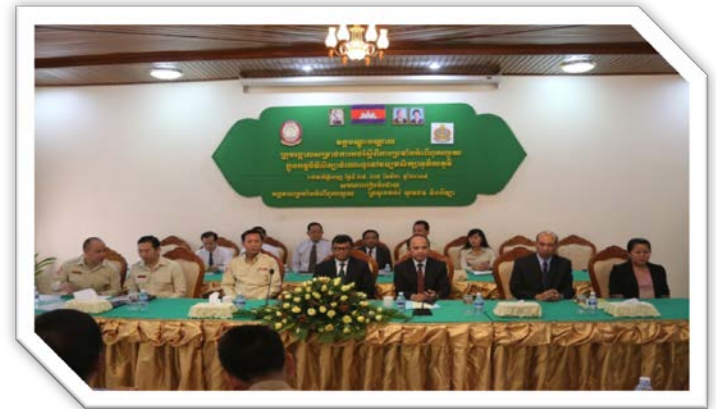
- Pilot teaching

2. Outside School Program

- **Two expected outcome:**
 - **Immediate benefit**
 - **Long-term benefit: Strengthened quality of youth – new mindset: Those with knowledge will pass the exam – regardless of their likelihood status quo**
